
INCIDENT REPORTS

Approximately 150 incidents were entered into NFIRS reporting system from the previous three months but due to a technical problem with NFIRS reporting system, a new reporting system was purchased and implemented. This new system made entering calls easier, and allowed for tracking the type of calls and personnel involved. It is also being used to write fire investigation reports and track the activity of the volunteers. This system also allows for printing out various informative reports.

The new system had to be installed and information entered before it could be used, which involved entering information on the apparatus, personnel, and all the streets in the city limits and County roads in our response area. After the system was operational each firefighter had to be trained on using the system. **The new system has been a success; it has made entering calls easier, and has allowed us to track and report fire department activity.** This new system also has allowed each working shift to enter they're own calls instead of one person entering all the calls. The next step in reporting calls will be adding the EMS module, which will allow for entering patient care information while meeting HEPA laws.

FIRE SAFETY

Fire education was preformed at Early Primary, Tuesday School, and Kids Tracks. Ricky Ray was asked to post fire prevention safety tips on the City of Early Facebook due to people being home more than usual for the holidays, or being quarantined. Fund raising was started for fire education materials for 2021. At the time of this report \$1520.00 has been donated.
